Community-based health centers, like Brevard Health Alliance, are keenly focused on increasing access to crucial primary care by reducing barriers such as cost, lack of insurance, distance, and language for their patients. Brevard, a community health center in Florida, is a thought leader in finding innovative ways to do well while doing good – supporting the health of their constituents while managing a successful enterprise.

Brevard was approached by a third-party to enter into a value-based arrangement. The third party offered to provide a solution that leverages advanced technology to streamline care delivery, improve data integration, and facilitate care. The third-party promised to reduce administrative burdens and enable providers to focus more on patient care. What's more, they offered their services for \*free\* if Brevard would agree to a small guarantee, plus a small share in VBC incentives, with the majority going to the third party.

The offer raised questions, as the Brevard team did not have the right data and analysis tools to understand if the proposal was equitable or actionable. The complexities and potential risks in the proposal highlighted the need for expert guidance in navigating such negotiations. 


